

RESOLUTION NO. 2017-09

A RESOLUTION of North Kootenai Water District, Kootenai County, Idaho, approving certain Capitalization Fees of the District; setting the schedule of Capitalization Fees of the District; and providing for other matters properly relating thereto.

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF NORTH KOOTENAI WATER DISTRICT, Kootenai County, Idaho, as follows:

WHEREAS, North Kootenai Water District (the "District") is a water district under and by virtue of the constitution and laws of the state of Idaho and is governed by an elected Board of Directors (the "Board");

WHEREAS, the Board has the statutory duty to operate, on a breakeven basis, the District's water utility system or systems (the "System") and to set the rates, fees, and charges necessary to maintain and operate the System;

WHEREAS, pursuant to the District's rules of operations and policies regarding Capitalization Fees (as defined in District Resolution No. 2015-09), the District has the duty to review and adjust, as necessary, the Connection Fees charged by the District; and

WHEREAS, the District has received information regarding certain Capitalization Fees charged by the District;

WHEREAS, pursuant to Idaho Code Section 63-1311A, no public hearing is required for the increase in such fees unless they are in excess of five percent (5%) of the amount last collected;

WHEREAS, the Board has considered and discussed the information it has received; and

WHEREAS, the Board desires to set the Capitalization Fees for the District as set forth in Exhibit "A" attached hereto and incorporated herein by this reference.

NOW, THEREFORE, IT IS HEREBY FURTHER RESOLVED as follows:

Section 1: Incorporation of Recitals. The Board hereby incorporates the recitals set forth herein as a part of this Resolution.

Section 2: Capitalization Fees for the District. The Capitalization Fees for the District shall be as set forth in Exhibit "A" attached hereto and incorporated herein by this reference. Unless otherwise set forth in Exhibit "A," all other rates, fees and charges for customers and users of the System shall remain in full force and effect, and as previously set and/or approved by the Board. The rates, fees, and charges set forth in Exhibit "A" shall be applicable on or after October 5, 2017.

Section 3: Ratification. The Board hereby ratifies all acts taken by members of the Board and/or agents on behalf of the Board or District relative to the implementation of new rates and charges.

Section 4: Severability. If any section, paragraph, clause, or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of each section, paragraph, clause, or provision shall in no manner affect any remaining provision of this Resolution.


Section 5: Effective Date. This Resolution shall become and is effective as of the date of its adoption.
