

RESOLUTION NO. 2013-12

A Resolution of North Kootenai Water District, Kootenai County, Idaho, declaring certain personal property of the District surplus to the needs of the District; providing for a process to advertise and sell such surplus property; providing for an effective date of this resolution; and providing for other matters properly relating thereto.

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE NORTH KOOTENAI WATER DISTRICT, Kootenai County, Idaho, as follows:

WHEREAS, North Kootenai Water District (the "District") is a water district under and by virtue of the constitution and laws of the state of Idaho and is governed by an elected Board of Directors ("Board"); and

WHEREAS, the District has certain personal property it wishes to declare as surplus to the needs of the District, a list of which is attached hereto as Exhibit "A" ("Surplus Property");

WHEREAS, the Board wishes to maximize the proceeds of sale it receives from the sale of such Surplus Property and wishes to set up a process to maximize these proceeds.

NOW, THEREFORE, IT IS HEREBY FURTHER RESOLVED as follows:

Section 1: Declaration of Surplus Property. The personal property listed in Exhibit "A" is hereby declared surplus to the needs of the District.

Section 2: Advertisement of the Sale of Surplus Property. The Manager of the District is hereby directed to use all legal and commercially reasonable means to sell the Surplus Property in any manner to maximize exposure of the potential sale of the Surplus Property.

Section 3: Sale of Surplus Property. After a reasonable time of advertising and providing other methods of notice of the sale of property, the District Manager is hereby authorized to sell the Surplus Property in a manner that maximizes proceeds to the District. The proceeds of the sale of the Surplus Property shall be deposited into the appropriate account of the District.

Section 4: Ratification. The Board hereby ratifies all acts taken by members of the Board and/or agents on behalf of the Board or District relative to the declaration and sale of the Surplus Property is hereby ratified and approved.

Section 5: Severability. If any section, paragraph, clause, or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of each section, paragraph, clause, or provision shall in no manner affect any remaining provision of this Resolution.

Section 6: Effective Date. This Resolution shall take effect and be in force and effect from and after its passage and approval.
