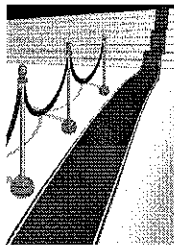

Envelopes ~

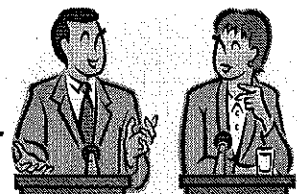
Many of you have been using the return envelope we provide with your monthly statement to mail payments to other companies. This is okay, but, you **MUST black out the bar code** located at the bottom of the envelope in addition to crossing out our address. If you DO NOT black out the bar code the Post Office still forwards the envelope to us at NKWD. **Not doing this may cause you to have a delinquent payment!**



Board Seats ~ Our Board of Directors is comprised of 5 officials elected by the District's constituents (you). Currently, there are two board seats that will expire in February 2009. A 3rd seat must also go through the election process in February 2009. This seat was filled by an appointed member when the seat was vacated early (previous member moved outside District boundaries) and must now go through an official election.

An **election** will be held on **February 3, 2009**, to fill these three board seats. If you would be interested in serving as a Director on the Board you may pick up a 'Declaration of Candidacy' form from our office or print one from our website: www.nkwsd.com.

The **cutoff** for District candidates to file their 'Declaration of Candidacy' with NKWD is Wednesday, **December 24th, 2008, at 12:00 noon.**
