Bank Generated Payments ~ For those of you who generate your water payment through your bank's online payment system, please verify your water account number! An incorrect account number can cause your payment to be posted to someone else's account!! While they would appreciate your generosity, it will make you very unhappy!!!

Local Improvement District No. 1 (LID No. 1) ~ If you are a customer of the Honeysuckle Hills area and have not made your LID No. 1 payment for 2009, it is now PAST DUE. Please remit your annual payment immediately.

IDWR Adjudication of Water Rights ~ The Idaho Department of Water Resources has begun the adjudication of water rights in Kootenai County. Some of you have received notices. If you own a private well, even if you only use it for irrigation or stock water, you should respond to the letter. Those of you on the North Kootenai Water District systems do not have to respond. Our office is handling the adjudication process. What is the adjudication? It is proving that the water you use from a well goes to beneficial use of the property that well serves. Meter Reading ~ All meters, except those in the Twin Lakes, Chilco, and East Seasons Acres areas, were read this month for the first time since December. As explained in last months newsletter, do not be surprised if your bill reflects an adjustment based on your actual monthly average vs. your estimated usage.



Backflow Testing Reminder ~ IDEQ requires anyone with an automatic sprinkler system to have the backflow protection device checked annually. If you have not scheduled your inspection yet, you need to do so as soon as possible.

Digging ~ Remember, you must **call 811** before digging for any reason, at any depth, at least **48 hours** prior to digging.
