LOCAL IMPROVEMENT DISTRICT NO. 1

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE NORTH KOOTENAI WATER DISTRICT, KOOTENAI COUNTY, IDAHO, as follows:

WHEREAS, the North Kootenai Water District, of Kootenai County, Idaho, (the "District"), adopted Ordinance No. 2008-01 on February 21, 2008, confirming the Assessment Roll for LID No. 1 and directing that notices be mailed to property owners within the boundaries of LID No. 1; and

WHEREAS, the Board of Directors ("Board") of the District wishes to reexamine one of the protest it denied, which may affect the amount of the Assessment Roll and thereby wishes to repeal Ordinance No. 2008-01 until such time as the Board has reviewed and disposed of this protest.

NOW, THEREFORE, BE IT FURTHER ORDAINED AS FOLLOWS:

Section 1: REPEAL OF ORDINANCE NO. 2008-01

Ordinance No. 2008-01 in its entirety is hereby repealed.

Section 2: EFFECTIVE DATE


This Ordinance shall be and is effective from and after the day of its adoption and publication, as required by law.
