RESOLUTION NO. 2014-06

A Resolution of North Kootenai Water District, Kootenai County, Idaho, approving the increase and/or establishment of certain rates, fees, and charges of the District; setting the schedule of certain rates, fees, and charges of the District; and providing for other matters properly relating thereto.

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE NORTH KOOTENAI WATER DISTRICT, Kootenai County, Idaho, as follows:

WHEREAS, North Kootenai Water District (the "District") is a water district under and by virtue of the constitution and laws of the state of Idaho and is governed by an elected Board of Directors ("Board"); and

WHEREAS, the Board has the statutory duty to operate, on a breakeven basis, the District's water utility system or systems (the "System") and to set the rates, fees, and charges necessary to maintain and operate the System; and

WHEREAS, the District has accumulated information about and evaluated the actual and estimated expenses of operating the System;

WHEREAS, pursuant to Idaho Code Section 63-1311A, the Board published public notice and conducted a public hearing on September 18, 2014 to provide an opportunity for the public to comment on the proposed increase in certain of the District's water system access fee and water rates;

WHEREAS, the Board has considered and discussed the information it has accumulated and comments and input received at the public hearing, as well as any telephone and written comments received by the District;

WHEREAS, the Board desires to set certain rates, fees, and charges for the System as set forth in Exhibit "A" attached hereto.

NOW, THEREFORE, IT IS HEREBY FURTHER RESOLVED as follows:

- Section 1: <u>Incorporation of Recitals.</u> The Board hereby incorporates the recitals set forth herein as a part of this resolution.
- Section 2: Rates, Fees and Charges of the System. The specific rates, fees, and charges for customers and users of the System and users shall be as set forth in Exhibit "A" attached hereto and incorporated herein by this reference. Unless otherwise set forth in Exhibit "A," all other rates, fees and charges for customers and users of the System shall remain in full force and effect, and as previously set and/or approved by the Board. The rates, fees, and

charges set forth in Exhibit "A" shall be applicable on or after October 1, 2014 including for any bills of statements transmitted on such date.

Section 3: Ratification. The Board hereby ratifies all acts taken by members of the Board and/or agents on behalf of the Board or District relative to the implementation of new rates and charges, and the hearing process is hereby ratified and approved.

<u>Section 4</u>: <u>Severability.</u> If any section, paragraph, clause, or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of each section, paragraph, clause, or provision shall in no manner affect any remaining provision of this Resolution.

Section 5: Effective Date. This Resolution shall become and is effective as of the date of its adoption.
